You accept responsibility that any members of your household, family, and other invited guests use the pool and other Association common areas at their own risk. By acceptance of this card, you understand and expressly acknowledge that you, on behalf of your household, family, or invited guests, hold harmless and indemnify the Association and all their respective officers, directors, agents, contractors, employees, heirs, successors, assigns, volunteers and guests from all liability for any injury, loss or damage connected in any whatsoever to your use of the pool or other Association common areas that may result from the Association's negligence, or design of the facility and/or equipment. All personal property brought to the pool or other Association common areas is brought at your sole risk as to its theft, damage, or loss. You acknowledge that the members of your household, family, or other invited guests will abide by any posted or published rules, procedures, or signs associated with the use of the Association's recreational and common facilities and violations may result in a suspension of privileges. You acknowledge that you may be held financially responsible for acts of mischief or vandalism by members of this household, family, or other invited guests that result in damage to the Association's equipment or facilities. If any provision of this Release if found to be invalid by a court of competent jurisdiction, the remaining portions and provisions of the

"Release" shall remain effective and shall be construed as if the invalid portion or provision had not been contained herein.
